

CRA RESOLUTION NO. R-2022-____

A RESOLUTION OF THE TOWN OF DAVIE COMMUNITY REDEVELOPMENT AGENCY APPROVING A SPONSORSHIP CONTRIBUTION IN THE AMOUNT OF \$2,500 FOR THE 2022 FLORIDA JUNIOR HIGH SCHOOL RODEO ASSOCIATION FINALS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Junior High School Rodeo Association is coming to the Bergeron Rodeo Grounds on September 16, 2022;

WHEREAS, a request has been received from the Weekley Brothers Davie Pro Rodeo LLC on behalf of the Florida Junior High School Rodeo Association to help sponsor the event in the amount of \$2,500;

WHEREAS, the request is consistent with the Town of Davie Community Redevelopment Plan which indicates the CRA should promote events which promotes the downtown area;

WHEREAS, the Town of Davie Community Redevelopment Agency has funds within the approved budget to provide the sponsorship.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE TOWN OF DAVIE COMMUNITY REDEVELOPMENT AGENCY.

SECTION 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town of Davie Community Redevelopment Agency as its legislative findings relative to the subjects and matters set forth in this Resolution.

SECTION 2. The Board of the Town of Davie Community Redevelopment Agency hereby approves a sponsorship contribution in the amount of \$2,500 to help sponsor the 2022 Florida Junior High School Rodeo Finals.

SECTION 3. Conflict. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 4. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town of Davie Community Redevelopment Agency that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

SECTION 5. Effective Date. This Resolution shall take effect immediately upon adoption.
