**RESOLUTION NO. R**

**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID AWARDED TO FLORIDA ENGINEERING AND DEVELOPMENT CORPORATION, FOR INDEFINITE DELIVERY-INDEFINITE QUANTITY CONSTRUCTION CONTRACT: PAVING ASPHALT/CONCRETE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Town is in need of an Indefinite Delivery-Indefinite Quantity Construction Contract for paving asphalt/concrete services;

WHEREAS, Sourcewell conducted competitive bids and awarded Contract FL-R6-PAC-092524-FEDC to Florida Engineering and Development Corporation, for paving asphalt/concrete services; and

WHEREAS, after review, the Town Council authorizes the Town to utilize the bid awarded by Sourcewell to Florida Engineering and Development Corporation, to provide an indefinite delivery-indefinite quantity construction contract with a service type of paving asphalt/concrete.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The Town Council of the Town of Davie does hereby accept the contract awarded for an indefinite delivery-indefinite quantity construction contract for paving asphalt/concrete services through Sourcewell Contract FL-R6-PAC-092524-FEDC.

Section 3. The Town Council hereby authorizes expenditure of funds over \$65,000 per year in accordance with the awarded contract prices, on an as-needed basis. Funding will come from approved accounts, dependent on usage and within established budgets.

Section 4. The initial contract term is effective through December 10, 2026, with the option to renew for three (3) additional one (1) year periods. Contract renewals, extensions, termination, and amendments/modifications will be handled administratively.

Section 5. Conflict. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 6. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 7. Effective Date. This Resolution shall take effect immediately upon adoption.
