A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, TAKING FINAL ACTION ON VARIANCE APPLICATION V25-026 5600 LLC; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the applicant applied for a variance pursuant to Chapter 12, Article X of the Town of Davie Code of Ordinances for the property at 5600 SW 61st Ave.; and

WHEREAS, the proposed variance would allow a reduction in the minimum required frontage of ten (10) single-family residence lots to 110 ft (town code normally requires a 125-ft. minimum) as set forth in Exhibit A; and

WHEREAS, all public notice requirements for the proposed variance have been met; and

WHEREAS, the proposed variance was considered by the Planning and Zoning Board on March 10, 2026; and

WHEREAS, the proposed variance was heard by the Town Council.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

- APPROVE the variance as proposed, subject to the following conditions:

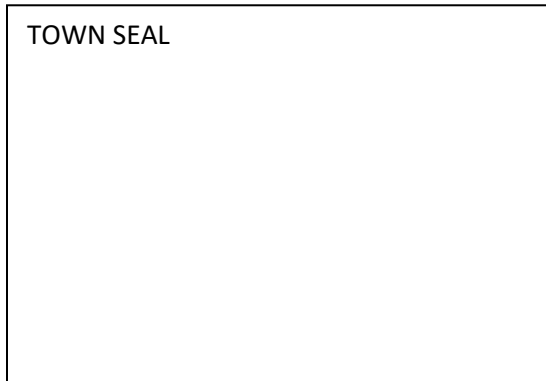
