ORDINANCE O 2026-

AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SECOND AMENDMENT TO THE FISCAL YEAR 2026 BUDGET; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Davie adopted its Fiscal Year 2026 Budget through Ordinance 2025-029 on September 17, 2025 and amended it through Ordinance 2026-004 on February 4, 2026; and

WHEREAS, periodic modifications to the estimated revenues and expenditures for the fiscal year may be necessary for fiscal management purposes and to implement decisions of the Town Council; and

WHEREAS, budget amendments are currently proposed for the General Fund, Water and Sewer Fund, and Self Insurance Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town Council of the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Ordinance.

Section 2. The Town Council approves the Budget Amendment for Fiscal Year 2026 that is attached as Exhibit A, including all budget transfers and amendments contained therein, and adopts the Amended Budget.

Section 3. The Town Council approves the revisions to the list of funded positions for Fiscal Year 2026 that is attached as Exhibit B.

Section 4. The Town Council authorizes the Town Administrator to execute intradepartmental budget transfers within the department budgets approved in "Exhibit A" so long as the net change in a department's total appropriation is zero. Budget transfers between departments which increase or decrease a department's budget and all budget amendments which increase or decrease the total budget require Town Council approval.

Section 5. Severability. If any provision of this Ordinance or the application

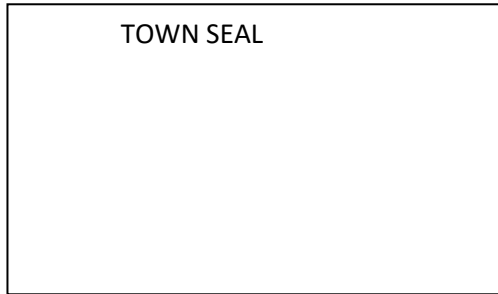
thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application and, to this end, the provisions of this Ordinance are declared severable.

Section 6. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict hereby repealed.

Section 7. Effective Date. This Ordinance shall take effect immediately upon passage and adoption.
