**RESOLUTION NO. R**

**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, APPROVING THE THIRD AMENDMENT TO THE 10-YEAR CAPITAL IMPROVEMENTS PROGRAM FOR THE TOWN OF DAVIE FOR FISCAL YEARS 2026-2035; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Town Council of the Town of Davie adopted the FY2026-2035 Capital Improvements Program budget on September 3, 2025;

WHEREAS, the Town Council of the Town of Davie adopted the first amendment to the FY2026-2035 Capital Improvements Program budget on January 21, 2026; and

WHEREAS, the Town Council of the Town of Davie adopted the second amendment to the FY2026-2035 Capital Improvements Program budget on March 18, 2026; and

WHEREAS, the Town Council desires to amend the approved plan and its budget to add, remove, or modify projects.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town Council of the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The proposed Capital Improvements Program budget, after public hearing, discussion, and amendments thereto, is hereby submitted in accordance with the Exhibits attached hereto.

Section 3. The Town Council of the Town of Davie does hereby approve the third amendment to the FY2026-2035 Capital Improvements Program (Exhibit A).

Section 4. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 5. Conflicts. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 6. Effective Date. This Resolution shall take effect on effect immediately upon its passage and adoption.
