RESOLUTION NO. R

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, RATIFYING, APPROVING AND AWARDING ITB-GR-26-20 LAWN MAINTENANCE OF CRA PROPERTIES TO EDJ SERVICE LLC; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town on behalf of the Town of Davie Community Redevelopment Agency solicited Bid ITB# GR-26-20 Lawn Maintenance of CRA Properties;

WHEREAS, the Town received three (3) responses from the following perspective vendors: Brightview Landscape Services, Inc. (\$85,800.00); EDJ Service LLC (\$89,480.04); and Arazoza Brothers Corp. (\$139,399.00);

WHEREAS, a local Davie vendor, EDJ Service LLC., provided a Best and Final Offer (BAFO) and is considered the lowest bidder at \$84,940.96;

WHEREAS, after review, the Davie Community Redevelopment Agency wishes to accept the bid from the lowest, most responsive, responsible bidder: EDJ Service LLC; and

WHEREAS, the Town Council of the Town of Davie, Florida hereby ratifies, approves and awards ITB# GR-26-20 Lawn Maintenance of CRA Properties to EDJ Service LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The Town of Davie hereby ratifies, approves and accepts the bid and awards ITB# GR-26-20 to EDJ Service LLC as the vendor to perform Lawn Maintenance of CRA Properties in the amount of \$84,940.96 with a list of optional services which may be used as-needed at an additional cost.

Section 3. The contract term is for three (3) years, with the option to renew for two (2) additional three (3) year periods. Contract renewals, extensions, termination, and amendments/modifications will be handled administratively.

Section 4. Cone of Silence. Upon approval by the Mayor and Council, pursuant to Town Code Section No. 2-320, the Cone of Silence is hereby terminated.

Section 5. Conflict. All resolutions or part of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 6. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town of Davie that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provision of the Resolution are declared severable.

Section 7. The Town Council hereby authorizes expenditure of CRA funds over \$65,000 per year in accordance with the awarded contract prices. Funding will come from approved accounts, and within the established CRA budget.

Section 8. Effective Date. This Resolution shall take effect immediately upon adoption.
