**RESOLUTION NO. R-2026-**

**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, TAKING FINAL ACTION ON VARIANCE APPLICATION V26-001 SALBO; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the applicant applied for a variance pursuant to Chapter 12, Article X of the Town of Davie Code of Ordinances for the property at 4115 Southwest 111th Lane; and

WHEREAS, the proposed variance would allow a new accessory garage building to be constructed at a height of 13'-11" as set forth in Exhibit A; and

WHEREAS, all public notice requirements for the proposed variance have been met; and

WHEREAS, the proposed variance was considered by the Planning and Zoning Board on April 7, 2026; and

WHEREAS, the proposed variance was heard by the Town Council.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

- APPROVE the variance as proposed, subject to the following conditions:

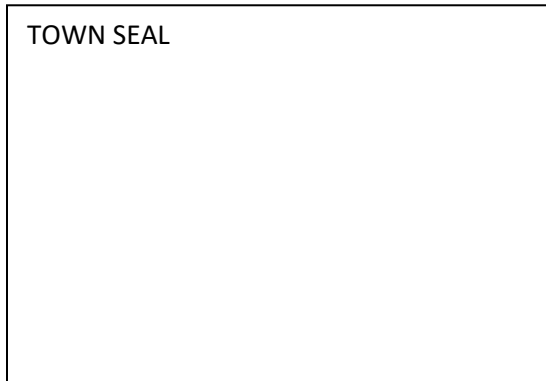
