**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, TAKING FINAL ACTION ON VARIANCE APPLICATION V25-180 EL CAR WASH; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the applicant applied for a variance pursuant to Chapter 12, Article X of the Town of Davie Code of Ordinances for the property at 2800 Davie Road; and

WHEREAS, the proposed variance would allow the proposed carwash building to be located 5 ft. from the north property line as set forth in Exhibit A; and

WHEREAS, all public notice requirements for the proposed variance have been met; and

WHEREAS, the proposed variance was considered by the Planning and Zoning Board on April 7, 2026; and

WHEREAS, the proposed variance was heard by the Town Council.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

- APPROVE the variance as proposed, subject to the following conditions:

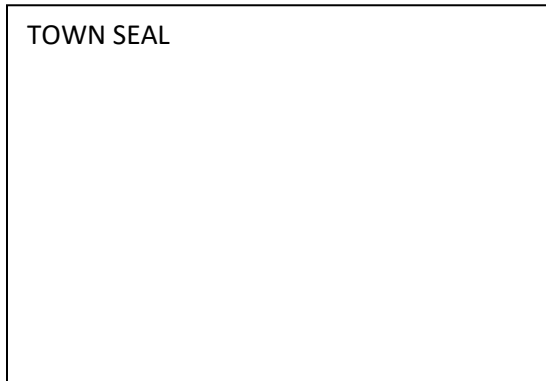
