

ADDENDUM TO THE PROFESSIONAL SERVICES AGREEMENT FOR SUNSHINE NURSING CARE, PLLC

This Addendum is made and entered into this day, May ____, 2026, and amends the existing professional services agreement for the community care provider program and related health services between the Town of Davie (“Owner”) and Sunshine Nursing Care, PLLC (“Contractor”) dated the 4th day of September 2024 (“Agreement”).

The purpose of this Addendum is to incorporate additional specified services related to the Florida Department of Health in Broward County’s Post Overdose Co-Responder Program Model for EMS Grant and to clarify the term of the Agreement.

Section 3 of the Agreement is hereby replaced and amended as follows:

The additional services agreed upon in this Addendum and the rights and responsibilities of the existing Agreement shall be performed starting upon the final signature below through August 31st, 2028, which is when the Grant concludes, unless extended in writing by both parties or terminated pursuant to Section 18 of the Agreement. Notwithstanding the foregoing, each party shall have the right to terminate this Agreement at any time upon giving thirty (30) calendar days written notice to the other party.

The subsequent language is added to Exhibit “A” Scope of Services of the Agreement:

- J. CONSULTANT shall align the program with Davie Fire Rescue’s EMS team’s capabilities and the goals of the Co-Responder Model to ensure timely and efficient response to community members in need.
- K. CONSULTANT shall assist Davie Fire Rescue on data collection, tracking the outcomes of the program, and contributing to the evaluation process to continuously improve service delivery.
- L. CONSULTANT shall work closely with Davie Fire Rescue and the Broward County Department of Health, law enforcement agencies, and community organizations to create a seamless and holistic response to mental health and substance abuse emergencies.

Conflict with Agreement

Except as modified by this Addendum, all terms and conditions of the Agreement remain in full force and effect. In the event of a conflict between the terms of this Addendum and the Agreement, the terms of this Addendum shall prevail.

Authorization and Effective Date

This Addendum shall become effective upon execution by authorized representatives of both parties.
