**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, TAKING FINAL ACTION ON VARIANCE APPLICATION V25-122 CAMERON COVE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the applicant applied for a variance pursuant to Chapter 12, Article X of the Town of Davie Code of Ordinances for the property at 2471-2871 Southwest 79th Avenue (Parcel ID Number 50-41-21-12-0070); and

WHEREAS, The proposed variance would allow a two-way private driveway 20ft. in width as set forth in Exhibit A; and

WHEREAS, all public notice requirements for the proposed variance have been met; and

WHEREAS, the proposed variance was considered by the Planning and Zoning Board on February 10, 2026; and

WHEREAS, the proposed variance was heard by the Town Council.

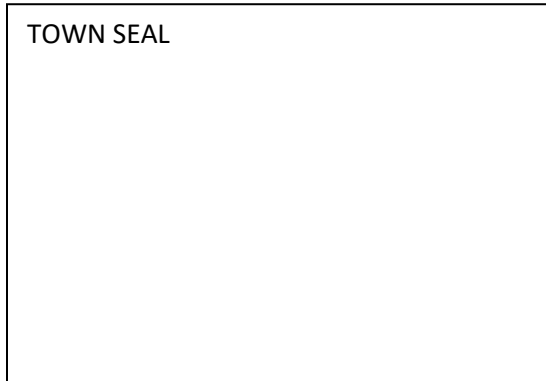
