RESOLUTION NO. R

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID RECOMMENDATION FOR ITB-CW-25-44 AWARDING ALL VENDORS FOR ID CARDS AND READERS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Town of Davie needs the ability to purchase equipment, products, software and services for the proper maintenance of the overall Town's enterprise infrastructure and applications;

WHEREAS, the Town solicited Invitation to Bid ITB-CW-25-44 for these renovations; and

WHEREAS, the Town received three (3) bid responses to ITB-CW-25-44;

WHEREAS, after review, the Town Council wishes to accept the recommendation of a line item award to Automated Port Services, Insight Public Sector, Inc. and Integrated Fire & Security Solutions, Inc. for ID Cards and Readers; and

WHEREAS, Automated Port Services is recommended as primary vendor for items #8, and #9, secondary vendor for items #1, 2, 13, and tertiary vendor for items #3, 4, 5, 6, 7, 14, 15. Insight Public Sector, Inc is recommended as primary vendor for items # 3 and 10, 11, 12, 13, 14, secondary vendor for items# 4, 5, 6, 7, 8, 9, 15, 16, 17, and tertiary vendor for items # 1, 2.

Integrated Fire and Security Solutions Inc is recommended as primary vendor for items # 1, 2, 4, 5, 6, 7, 15, 16, 17, secondary vendor for items # 3, 10, 11, 12, 14, and tertiary vendor for items #1, 2, 8, 9, 13.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The Town Council hereby authorizes expenditures of funds over \$65,000 per year in accordance with the awarded line item contract prices, on an as-needed basis. Funding will come from approved accounts, dependent on usage and within established budgets.

Section 3. The Town Council hereby accepts the recommendation of a line-item award to Automated Port Services, Insight Public Sector, Inc. and Integrated Fire & Security Solutions, Inc. The Town reserves the right to utilize the secondary vendor for order placement in the event that the primary vendor is unable to fulfill orders due to item unavailability, cannot provide delivery according to the Town's timelines, or emergencies arise. Additionally, the Town reserves the right to activate the secondary vendor in the event that the primary vendor is unable to perform in accordance with the contract terms. Likewise, the Town reserves the right to utilize or activate the tertiary vendor under the same circumstances should the secondary vendor be unable to meet the Town's requirements or perform in accordance with the contract terms. Once a quote has been requested by the Town of Davie, all vendors will have 48 hours to provide the Town with a quote for the required products. If the requested quote is not received within 48 hours of being requested, the Town will reserve the right to request a quote from the secondary or tertiary vendors for said products.

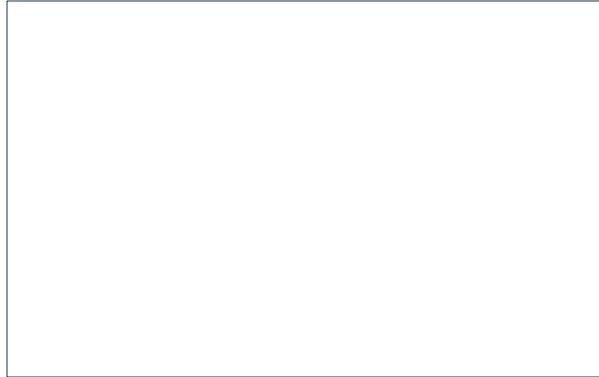
Section 4. Cone of Silence. Upon approval of the Mayor and Council, pursuant to Town Code Section No. 2-320, the Cone of Silence is hereby terminated.

Section 5. Conflict. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 6. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 7. Effective Date. This Resolution shall take effect immediately upon adoption.
