**RESOLUTION NO. R**

**A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, QUALIFYING AND AWARDED THE TOP TWO RANKED PROPOSERS IN RESPONSE TO REQUEST FOR PROPOSALS NO. RS-25-56 ELECTRIC VEHICLE (EV) CHARGING STATIONS-FURNISH, INSTALL, OPERATE, & MAINTAIN, WHICH WAS SOLICITED TO QUALIFIED AND EXPERIENCED CONTRACTORS TO FURNISH, INSTALL, OPERATE, AND MAINTAIN NETWORKED ELECTRIC VEHICLE (EV) CHARGING STATIONS AT VARIOUS TOWN-OWNED SITES, AND AUTHORIZING THE TOWN ADMINISTRATOR OR DESIGNEE TO NEGOTIATE A CONTRACT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Town solicited RFP# RS-25-56 Electric Vehicle (EV) Charging Stations: Furnish, Install, Operate & Maintain, seeking proposals from qualified and experienced contractors to furnish, install, operate, and maintain networked Electric Vehicle (EV) charging stations at various Town-owned sites.

WHEREAS, the Review Committee evaluated responses and ranked firms in accordance with the Town policies and procedures;

WHEREAS, the Review Committee's recommendation is to commence negotiations in the following order, in accordance with the Committee's ranking, until an agreement is negotiated: 1) EVERGED and 2) CJ Development Group, LLC;

WHEREAS, the final negotiated agreement will be brought to a future Council Meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town Council of the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The Town Council of the Town of Davie does hereby award the top two (2) ranked firms and authorizes the Town Administrator or designee to negotiate with the firms in the following order until an agreement is reached: 1) EVERGED and 2) CJ Development Group, LLC;

Section 3. The final negotiated agreement will be brought to the Council for approval at a future meeting date.

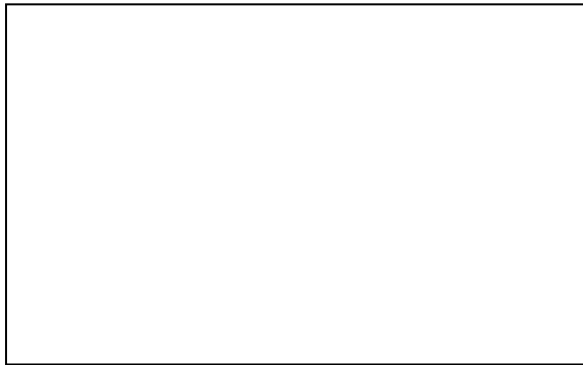
Section 4. Cone of Silence. Upon approval of the Mayor and Council, pursuant to Town Code Section No. 2-320, the Cone of Silence is hereby terminated.

Section 5. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 6. Conflicts. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 7. Effective Date. This Resolution shall take effect on effect immediately upon its passage and adoption.
