Procurement Comments:

The Town received nine (9) bid responses from the following bidders: SFM Landscape Services, LLC., Hands On Development LLC, E.Rodriguez Landscaping Inc., Juniper Landscaping of Florida LLC, Green Dreams Paradise Corp., AR Maintenance Solutions, EDJ Service LLC, Brightview Landscape Services, Inc., and Superior Landscaping & Lawn Service Inc. Hands On Development LLC was disqualified for failure to attend the mandatory pre-bid conference. AR Maintenance Solutions was disqualified due to an expired limited commercial fertilizer applicator license, and Green Dreams Paradise Corp was disqualified due to falsifying the expiration date of the Temporary Traffic Control (formerly the Maintenance of Traffic) certification. The two (2) lowest bidders for Zone 2, EDJ Service LLC, and Juniper Landscaping of Florida LLC both qualified for local preference as local Davie vendors. Both firms were eligible to submit a Best and Final offer (BAFO). EDJ Service LLC withdrew their BAFO response due to a math error. Juniper Landscaping of Florida LLC submitted the lowest BAFO for Zone 2.
