A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AWARDED BID ITB# RS-26-16 FOR RIGHT OF WAY LANDSCAPE MAINTENANCE FOR ZONE 1 TO E. RODRIGUEZ LANDSCAPING INC. FOR AN ANNUAL BASE PRICE OF \$285,960 AS THE PRIMARY VENDOR, JUNIPER LANDSCAPING OF FLORIDA, LLC FOR A BASE PRICE OF \$436,720 AS THE SECONDARY VENDOR, AND BRIGHTVIEW LANDSCAPE SERVICES, INC. FOR A BASE PRICE OF \$492,290 AS THE TERTIARY VENDOR, FOR ZONE 2 TO JUNIPER LANDSCAPING OF FLORIDA, LLC FOR AN ANNUAL BASE PRICE OF \$217,264 AS THE PRIMARY VENDOR, EDJ SERVICE LLC FOR A BASE PRICE OF \$220,571.58 AS THE SECONDARY VENDOR, AND BRIGHTVIEW LANDSCAPE SERVICES, INC. FOR A BASE PRICE OF \$241,054 AS THE TERTIARY VENDOR AND FOR ZONE 3 TO E. RODRIGUEZ LANDSCAPING INC. FOR AN ANNUAL BASE PRICE OF \$212,482 AS THE PRIMARY VENDOR, JUNIPER LANDSCAPING OF FLORIDA, LLC FOR A BASE PRICE OF \$232,925 AS THE SECONDARY VENDOR, AND EDJ SERVICE LLC FOR A BASE PRICE OF \$234,960.06 AS THE TERTIARY VENDOR; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town is in need of right of way landscape maintenance services;

WHEREAS, the Town bid for these Services from ITB# RS-26-16 and received nine (9) responses;

WHEREAS, the bid included three (3) landscape maintenance zones, and it is specified that the Town will award to multiple bidders based on the pre-identified landscape maintenance zones;

WHEREAS, after review of the bids, staff concurs to award the bid for Zone 1 to E. Rodriguez Landscaping Inc. for an annual base price of \$285,960 as the primary vendor, Juniper Landscaping of Florida, LLC for a base price of \$436,720 as the secondary vendor, and Brightview Landscape Services, Inc. and for a base price of \$492,290 as the tertiary vendor, for Zone 2 to Juniper Landscaping of Florida, LLC for an annual base price of \$217,264 as the primary vendor, EDJ Service LLC for a base price of \$220,571.58 as the secondary vendor, and Brightview Landscape Services, Inc. for a base price of \$241,054 as the tertiary vendor and for Zone 3 to E. Rodriguez Landscaping Inc. for an annual base price of \$212,482 as the primary vendor, Juniper Landscaping of Florida, LLC for a base price of \$232,925 as the secondary vendor, and EDJ Service LLC for a base price of \$234,960.06 as the tertiary vendor; and

WHEREAS, after review, the Town Council wishes to accept the bids from E. Rodriguez Landscaping Inc. (Zone 1), Juniper Landscaping of Florida, LLC (Zone 2), and E. Rodriguez Landscaping Inc. (Zone 3) as primary vendors, and from Juniper Landscaping of Florida, LLC (Zone 1), EDJ Service LLC (Zone 2), and Juniper Landscaping of Florida, LLC (Zone 3) as secondary

vendors, and from Brightview Landscape Services, Inc. (Zone 1), Brightview Landscape Services, Inc. (Zone 2), and EDJ Service LLC (Zone 3) as tertiary vendors.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA THAT:

Section 1. Legislative Findings/Recitals. The above recitals are hereby adopted by the Town Council of the Town of Davie as its legislative findings relative to the subjects and matters set forth in this Resolution.

Section 2. The Town Council of the Town of Davie does hereby approve ITB# RS-26-16 for Zone 1 to E. Rodriguez Landscaping Inc. for an annual base price of \$285,960 as the primary vendor, Juniper Landscaping of Florida, LLC for a base price of \$436,720 as the secondary vendor, and Brightview Landscape Services, Inc. and for a base price of \$492,290 as the tertiary vendor, for Zone 2 to Juniper Landscaping of Florida, LLC for an annual base price of \$217,264 as the primary vendor, EDJ Service LLC for a base price of \$220,571.58 as the secondary vendor, and Brightview Landscape Services, Inc. for a base price of \$241,054 as the tertiary vendor and for Zone 3 to E. Rodriguez Landscaping Inc. for an annual base price of \$212,482 as the primary vendor, Juniper Landscaping of Florida, LLC for a base price of \$232,925 as the secondary vendor, and EDJ Service LLC for a base price of \$234,960.06 as the tertiary vendor.

Section 3. The Town Council hereby authorizes expenditure of funds over \$65,000 per year in accordance with the awarded contract unit prices, on an as-needed basis. Funding will come from approved Town accounts, dependent on usage and within established budgets.

Section 4. The initial contract shall be for a period of two (2) years from execution of the agreement. In addition, the Town reserves the right to renew the contract for two (2) additional two (2) year periods, providing that both parties agree that all terms, conditions and specifications remain the same, contingent upon approval by the Town Administrator.

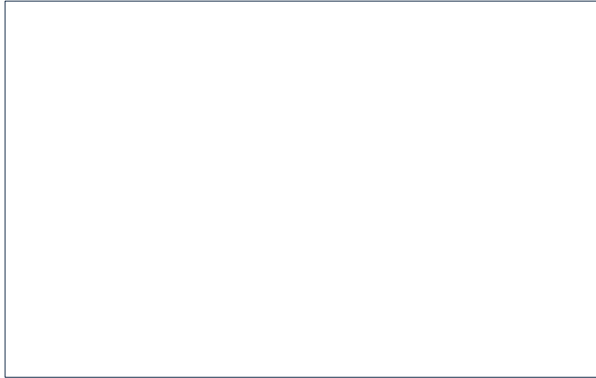
Section 5. The Town reserves the right to administratively activate the secondary vendor(s) Juniper Landscaping of Florida, LLC for Zone 1, and/or EDJ Service LLC for Zone 2, and/or Juniper Landscaping of Florida, LLC for Zone 3 in the event one or more of the primary vendor(s) is unable to perform as required per the agreement and administratively activate the tertiary vendor(s) Brightview Landscape Services, Inc. for Zone 1, and/or Brightview Landscape Services, Inc. for Zone 2, and/or EDJ Service LLC in the event one or more of the secondary vendor(s) is unable to perform as required per the agreement.

Section 6. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Town Council that such invalidity shall not affect other provisions or applications of the Resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this Resolution are declared severable.

Section 7. Conflicts. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Section 8. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
